Policy Introduction & Purpose

As a secondary academy school, we must provide RSE to all pupils as per section 34 of the <u>Children</u> and Social work act 2017.

In teaching RSE, we are required by our funding agreements to have regard to <u>guidance</u> issued by the secretary of state as outlined in section 403 of the <u>Education Act 1996</u>. At Hall Cross Academy, we teach RSE as set out in this policy.

Policy Aims

The aims of relationships and sex education (RSE) at Hall Cross Academy are to:

- Provide a framework in which sensitive discussions can take place
- Prepare pupils for puberty, and give them an understanding of sexual development and the importance of health and hygiene
- Help pupils develop feelings of self-respect, confidence and empathy
- Create a positive culture around issues of sexuality and relationships
- Teach pupils the correct vocabulary to describe themselves and their bodies

Policy Scope

This policy applies to all Hall Cross Academy employees, Governors, contractual third parties and partner organisation employees who have access to data held or provided to/by the academy. This includes permanent and temporary staff, consultants, contractors and partner companies.

Consultation

This policy has been developed in consultation with staff, pupils and parents. The consultation and policy development process involved the following steps:

- 1. Review a member of staff or working group pulled together all relevant information including relevant national and local guidance
- 2. Staff consultation all school staff were given the opportunity to look at the policy and make recommendations
- 3. Parent/stakeholder consultation parents and any interested parties were invited to attend a meeting about the policy
- 4. Pupil consultation we investigated what exactly pupils want from their RSE
- 5. Ratification once amendments were made, the policy was shared with governors and ratified

Policy / Controls

RSE is learning about the emotional, social and physical aspects of growing up, relationships, sex, human sexuality and sexual health. It should equip children and young people with the information, skills and values to have safe, fulfilling and enjoyable relationships and to take responsibility for their sexual health and wellbeing. RSE involves a combination of sharing information and exploring issues and values.

RSE is not about the promotion of sexual activity.

Our curriculum is set out as per Appendix 1 but we may need to adapt it as and when necessary. We have developed the curriculum in consultation, taking into account the age, needs and feelings of pupils. If pupils ask questions outside the scope of this policy, teachers will respond in an appropriate manner so that students are fully informed.

RSE is taught within the Life curriculum. Biological aspects of RSE are taught within the science curriculum.

Pupils will be supported with developing the following skills:

- Communication, including how to manage changing relationships and emotion
- Recognising and assessing potential risks
- Assertiveness
- Seeking help and support when required
- Informed decision –making
- Self-respect and empathy for others
- Recognising and maintaining a healthy lifestyle
- Managing conflict
- Discussion and group work

RSE focuses on giving young people the information they need to help them develop healthy, nurturing relationships of all kinds including:

- Families
- Respectful relationships including friendships
- Online and media
- Being safe
- Intimate and sexual relationships, including sexual health

These areas of learning are taught within the context of family life taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBT parents, families headed by grandparents, adoptive parents, foster parents/carers

amongst other structures) along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers).

The governing body

The governing body will approve the RSE policy, and hold the Principal to account for its implementation.

The Principal

The Principal is responsible for ensuring that RSE is taught consistently across the school, and for managing requests to withdraw pupils from non-statutory components of RSE (see section 8).

Staff

Staff are responsible for:

- Delivering RSE in a sensitive way
- Modelling positive attitudes to RSE
- Monitoring progress
- Responding to the needs of individual pupils
- Responding appropriately to pupils whose parents/carers wish them to be withdrawn from the non-statutory components of RSE

Staff do not have the right to opt out of teaching RSE. Staff who have concerns about teaching RSE are encouraged to discuss this with the Principal.

RSE will be delivered by members of the Life department.

Pupils

Pupils are expected to engage fully in RSE and, when discussing issues related to RSE, treat others with respect and sensitivity.

Parents

Parents have the right to withdraw their children from the non-statutory components of sex education within RSE up to and until 3 terms before the child turns 16. After this point, if the child wishes to receive sex education rather than being withdrawn, the school will arrange this.

Requests for withdrawal should be put in writing using the form found in Appendix 3 of this policy and addressed to the Principal.

A copy of withdrawal requests will be placed in the pupil's educational record. The Principal will discuss the request with parents and take appropriate action.

Alternative work will be provided for pupils who are withdrawn from sex education.

Staff are trained on the delivery of RSE as part of their induction.

The Principal will also invite visitors from outside the school, such as school nurses or sexual health professionals, to provide support and training to staff teaching RSE as necessary.

Policy Review & Development

The delivery of RSE is monitored by the Philosophy and Ethics department (KS 4-5) and the Baccalaureate department (KS 3) through the Quality Assurance Programme of learning walks, book scrutiny and student voice as detailed in the school calendar.

Pupils' development in RSE is monitored by class teachers through the use of 'I can..' statements, but is not formally assessed using the 9-1 grading system used by other subject areas.

This policy will be reviewed by Mrs. Fielding (Associate Assistant Principal) every 2 years. At every review, the policy will be approved by the governing body.
