Policy Introduction and Purpose

Hall Cross Academy recognises and values the importance of allowing other education and training providers access to schools to speak directly with students.

Hall Cross not only supports this but encourages this access in order to enable our students to make more informed decisions about their future.

The impact of speaking with other providers and employers can have a real positive effect for our students: they are able to receive impartial advice and guidance along with learning more in depth information regarding their potential future choices. We also want students to be able to understand technical education and apprenticeship opportunities and where these pathways can lead them. We want students to be aware of all routes whether that be post 14, 16 or 18.

In addition, this helps support the academy in working towards meeting all Gatsby Benchmarks (detailed within the Careers Policy) and develop the careers programme we offer.

Policy Aims: The aim of this policy is to set out clear guidance on how other education/training providers can access the academy and speak with students.

This document sets out the school's arrangements for managing the access of providers to pupils at the school for the purpose of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997.

Hall Cross Academy Pupil entitlement

All pupils in years 8 to 13 are entitled:

- to find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point;
- to hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through options events, assemblies and group discussions and taster events;
- to understand how to make applications for the full range of academic and technical courses.

Hall Cross Academy will ensure the following mandatory requirements are put in place for students in Year 8 - 13:

- **Two encounters for pupils during the 'first key phase' (year 8 or 9)** that are mandatory for all pupils to attend, to take place any time during year 8 or between 1 September and 28 February during year 9.
- **Two encounters for pupils during the 'second key phase' (year 10 or 11)** that are mandatory for all pupils to attend, to take place any time during year 10 or between 1 September and 28 February during year 11.
- **Two encounters for pupils during the 'third key phase' (year 12 or 13)** that are mandatory for the school to put on but optional for pupils to attend, to take place any time during year 12 or between 1 September and 28 February during year 13.

These provider encounters will be scheduled during the main school hours and the provider will be given a reasonable amount of time to, as a minimum:

- share information about both the provider and the approved technical education qualification and apprenticeships that the provider offers
- explain what career routes those options could lead to
- provide insights into what it might be like to learn or train with that provider (including the opportunity to meet staff and pupils from the provider)
- answer questions from pupils.

Policy Scope: The purpose of this policy is to set out the times at which access is to be given and explain how the school will meet the new legal requirement to put on six provider encounters. It also provides clear information and guidance on how providers can seek access to the school and speak directly with students.

The policy supports the statutory requirements of schools to comply with the Provider Access Legislation through the changes to the Skills and Post-16 Education Act 2022, which come into effect on 1 January 2023.

In addition, the policy applies to the staff at Hall Cross Academy to understand and follow should anyone contact them directly regarding attending the school to speak to students.

Policy/Controls

Hall Cross Academy offers a comprehensive Careers Education, Information, Advice and Guidance programme and is committed to continuing to develop and support its students in their future and progression. Allowing access to education and training providers is not only a crucial element for a student's careers programme but helps educate them and raise awareness of the different opportunities available to them, including technical education and apprenticeships.

Premises and Facilities - The academy will make the main hall, sports hall, sixth form centre, library, classrooms or private meeting rooms available for education and training providers; giving them the opportunity to speak with students.
